

ORGANIZATIONAL MEETING

SOUTHAMPTON FIRE DISTRICT

JANUARY 6, 2010

The Organizational Meeting of the Board of Commissioners of the Southampton Fire District was called to order by Treasurer Hadix, who was appointed Temporary Chairman, at 7:30 PM, on Wednesday, January 6, 2010, in the Library of the Tuckahoe School, 468 Magee Street, Southampton, New York, in accordance with notice provided to the news media, copy of which is attached hereto. The meeting opened with the salute to the flag.

Mr. Hadix stated that the purpose of the meeting was the organization of the Southampton Fire District Board of Commissioners for the year 2010.

Motion by Commissioner **Price** that the Treasurer is hereby directed to maintain general Capital Reserve Funds pursuant to the provisions of Section 6-g of the General Municipal Law of the State of New York for the general purposes of capital improvements and the purchase of apparatus and equipment, all as further set forth below:

a) Capital Reserve Fund – Buildings and Grounds: This fund is to be used for capital improvements concerning the purchase of real property, the design and construction of new buildings, renovations and/or additions to existing buildings and real property and other lawful purposes as may from time to time arise. This fund shall have no maximum cap amount at this time.

b) Capital Reserve Fund – Apparatus and Equipment: This fund is to be used for the purchase of items which are capable of being classified as capitalized expenditures under the law, which items include, but are not limited to fire trucks, chief’s vehicles, ambulances, fire police and/or any general utility vehicles, SCBA’s, hose, turnout gear, mechanical and communications equipment, computers and other lawful purposes as may from time to time arise. This fund shall have no maximum cap amount at this time.

Committee Reports-

Fire District Budget -

Fire Protection Contract – The District is entering the first year of a 3 year contract with the Village of Southampton for fire protection. The first payment to the Village of Southampton will be due in February.

Long Range Planning – Mr. White was able to spend some time with and conduct his interview with Charles Jennings of Manitou Inc. after our meeting of December 10, 2009. We have since received a request for Data pertaining to the following sectors, the Southampton Fire District, the Town of Southampton, The Village of Southampton and the Southampton Village Fire Department. The Commissioners discussed who would be the point of contact in each of these sectors. The secretary disclosed her contact at with the Town for the creation of digital mapping. The outgoing treasurer will provide all financial materials needed. The secretary will dissect the data request to insure the correct data is asked of the correct sectors.

Wells, Hydrants & Water Mains – The Commissioners with Mr. Corr discussed the problems with the last snow storm where 28 inches of snow fell in 24hrs. The road clearing was at a slow pace with many of the outlying areas remaining up plowed for 48 hrs and many roads only plowed one lane wide. There is a concern with the access for emergency response to the areas where plowing lagged by days post storm. There were many instances where privately hired snow plows “plowed in” hydrants; i.e. piled snow towards hydrants in some instances placing 6 feet of snow over hydrants. Fortunately the snow melted within a week but had it remained cold it would be a huge financial undertaking to free all hydrants in the district. The question was raised as to liability of these buried hydrants, is it the District, the SCWA, or even the private snow plows or

business/residents who hired them. The District will check with counsel as to the liability of hydrant snow removal. It was addressed that this is not a regular occurrence and could be seen as a “20 year” storm.

Old Business – A proposal from William Glass to continue with our legal representation for the year of 2010 was reviewed by the Commissioners.

A motion was made by Mr. White and seconded by Mr. Hadix to continue to retain William F. Glass Jr. as legal representation for 2010. The motion was passed by the following vote:
