Committee Reports-

Fire District Budget - In use, planning for 2015 will begin in the next month or two.

Fire Protection Contract – The Commissioners continue to be disappointed that the Chiefs are not able to attend the District meeting and that the monthly paper work is not being submitted. The Secretary will draft a letter to the Village highlighting the specific items in our contract that are not being met.

Long Range Planning – The district board has requested a long range plan from the Village Board and the Village Fire Department for capital reserve and 7 year equipment purchase plan.

Wells, Hydrants & Water Mains – A water main extension is under way in the Middle Pond Area of Tuckhoe, Shinnecock Hills. The secretary will contact the SCWA as there are conflicting maps. Hydrants to be placed accordingly.

Old Business – Elite Towers, a cell phone tower company, returned before the board to clarify information made in a previous presentation. The Commissioners will review and discuss the options as well as contact council to proceed with the plans.

A motion was made by Mr. Wines and seconded by Mr. Pell to draft a letter of intent with Elite Towers, giving Elite Towers the ability to move forward and collect more data and information to present to the Board. The motion was approved by the following vote:
